Information on personal data processing pursuant to Article 13 of EU Regulation 2016/679 of 27 April 2016



Pursuant to Article 13 of EU Regulation 2016/679 of 27 April 2016 "General Data Protection Regulation" (GDPR), **SEAM SpA - Società Esercizio Aeroporto Maremma** with registered office in Via Orcagna, 125 - 58100 Grosseto, as data controller of personal data, informs you about the following:

Data controller

The data controller is **SEAM SpA - Società Esercizio Aeroporto Maremma** in the person of its legal representative.

Purpose of data processing

Personal data provided to SEAM will be processed only for the following purposes:

a) provision of airport services and other services offered by SEAM SpA - Società Esercizio Aeroporto Maremma, fulfillment of statutory obligations, regulations, applicable legislation and other provisions issued by law enforcement authorities and by supervisory and control bodies. Processing of personal data for mentioned purposes does not require express consent of the data subject (Article 6 points b) and e) of GRDP)

Obligatory provision of data and consequences of any refusal to provide personal data

The provision of data required for the purposes set out in subparagraph a) above is mandatory by law and/or for the conclusion and execution of the contract and the requested services, therefore any refusal, even partial, to provide such data would result in the impossibility for the supplier to establish and manage the report itself and to provide the requested service.

Data processing methods

The processing of personal data is carried out with the operations indicated in art. 4 No. 2) GRDP, for the above purposes, both on paper and computer-based, by means of electronic instruments or in any case automated, in compliance with the regulations in force in particular regarding confidentiality and security and in conformity with the principles of correctness, lawfulness and transparency and protection of Customer rights.

Communication and dissemination

Your personal data may be communicated, within the limits strictly relevant to the obligations, tasks and purposes referred to above and in compliance with the applicable law in this field, to the following categories of subjects:

- 1. Persons to whom such communication must be carried out in order to fulfill or require the fulfillment of specific obligations under laws, regulations and/or Community legislation;
- External natural and/or legal persons providing services instrumental to the holder's activities for the purposes set out in paragraph 1. above (e.g. consultants, companies, institutions, professional firms, etc.). These subjects will operate as responsible for the treatment.

Personal data will not be subject to dissemination in any way.

Period of personal data storage

The personal data will be kept for the entire duration expressed by the contract concluded with the data controller and according to the terms prescribed by law for the preservation of administrative documents, then will be deleted.

Data transfer

Personal data is stored on servers located within the European Union. By the way the data controller, if necessary, will have the right to move the servers also extra-EU. In this case, the controller shall ensure that the transfer of the extra-EU data will be in conformity with the applicable legal provisions, subject to the stipulations of the standard contractual clauses laid down by the European Commission.

Rights of the data subject

The data subject has the following rights mentioned in art. 15 GRDP:

1. Obtain confirmation of the existence or not of personal data concerning it, even if not yet registered, and their communication in intelligible form;

2. Obtain the indication:

- a) of the origin of the personal data;
- b) of the purposes and modalities of treatment;
- c) of the logic applied in the case of treatment carried out with the aid of electronic instruments;
- d) the identification details of the data controller, the persons responsible;
- e) of the people or categories of persons to whom personal data may be communicated or which may be known to them as a designated representative in the territory of the State, of persons responsible or in charge;

3. Get:

- a) the updating, rectification or, when interested, the integration of data;
- b) the cancellation, the processing anonymously or the blocking of the data processed in violation of the law, including those whose preservation is not necessary in relation to the purposes for which the data has been collected or subsequently processed;
- c) the attestation that the transactions referred to in (a) and (b)) have been brought to the attention, including with regard to their content, of those to whom the data have been communicated, except in cases where such fulfillment proves to be impossible or involves a use of means manifestly disproportionate in respect of the protected law;

4. Oppose, in whole or in part:

- a) for legitimate reasons for the processing of personal data concerning it, even if relevant to the purpose of the collection;
- b) the processing of personal data relating to it for the purposes of sending advertising or direct sales material or for the completion of market research or commercial communication through the use of automated call systems without the intervention of an operator by e-mail and/or by traditional marketing methods by telephone and/or paper mail.

It is stated that the right of opposition of the person concerned, as set out in point B above, for direct marketing purposes by means of automated methods extends to the traditional ones and that, however, remains the possibility for the person concerned to exercise the right of opposition even in part. Therefore, the person concerned may decide to receive only communications by traditional means or only automated communications or none of the two types of communication. Where applicable, it also has the rights set out in the arts. 16-21 RGPD (right of adjustment, right to oblivion, right of limitation of treatment, right to data portability, right of opposition), and the right to claim to the Supervisory Authority.
